Post Graduate Diploma in Global Business Operations (GBO) OBE Examinations 2020 August

Relevant Information - Must to be read for all concerned

It is to inform to all the students of Semester IV, ex-students and students appearing for semester II examination along with Semester IV Examinations in July 2020 in ER and improvement cases (as per the rules) that taking into consideration the University of Delhi Notification Ref. No./ Dean(Exams.)/ 2020/ dated July 15, 2020 and SRCC GBO Notification dated July 8, 2020, **examinations will start from 10 August 2020** rather than after 16 August 2020 (as mentioned in the notifications referred above). The following points are also to be noted in this regard by all the concerned:

- 1. The exams will be conducted from 10 August 2020 onwards in the OBE mode remotely.
- 2. The date sheet is available on www.srcc.edu.
- 3. Students who for any reason are not able to appear in the examinations in OBE mode remotely which are scheduled to begin from 10 August 2020, will be dealt as per the guidelines of University of Delhi in this regard [For detail, kindly refer point 3 of the DU Notification Ref. No./ Dean(Exams.)/2020 dated July 15, 2020].
- 4. Student who have not yet filled the examination form can fill the form latest by 24 July 2020.
- 5. For any correction in the examination form (viz., mobile number, email, paper name, paper code, etc.), kindly contact Dr. Naveen Mittal, Deputy Superintendent GBO Exams at 9891935186 or meenav22@gmail.com latest by 26 July 2020.
- 6. The guidelines as issued by University of Delhi on 1 June 2020 related with the conduct of OBE for Postgraduate courses shall be applicable (*except* point 17 of the guidelines issued on 1 June 2020) for the rescheduled examinations to be conducted as per the revised date sheet.


Point 17 of those guidelines is "The University cares for those students who are not able to appear for the OBE remotely and thus will give such students one more chance to appear for the conventional mode of examinations as and when the present situation improves. The conventional mode of examinations in such case if required shall be conducted after the publication of results of OBE. The fresh dates for filling in the examination forms for the leftout students of the final semester/term/year

shall be notified probably by the beginning of September, 2020." This point is not applicable now as per the revised guidelines. Kindly keep note of this change.

- 7. All the facilities extended to the students under the Divyaang (PWD) category in general and the Visually Impaired students in particular such as provision of study material/reference texts, assistive devices and the facility of scribe for the OBE shall continue to be applicable for the rescheduled examinations. (Reference: DU Notifications issued on 04.06.2020, 22.06.2020, 29.06.2020 and all notifications issued by SRCC GBO in this regard).
- 8. Facilities available at college will be made accessible to students belonging to PWD category in general and Visually Impaired (VI) in particular, so that ICT infrastructure is available to the students with the prior information during the schedule examination in OBE mode to be conducted remotely. The facility will be available to other students as well with prior information and with the conditions of adherence of guidelines of social distancing and safety measures.
- 9. As notified earlier, the facilities of ICT infrastructure to be provided to the students for the OBE at the Common Service Centre (CSC) engaged by the University shall be made available to the students for the rescheduled examinations also as per the new date sheet notified. (Reference: DU Notifications issued on 01.06.2020 and 22.06.2020).
