

Dear Sir,

The department organizes various Awareness Programs, Health Melas and other events at regular intervals to sensitize and educate persons/firms involved in any kind of food business about clean and safe food. Mission "Sehatmand Delhi" is another milestone in this direction.

It has been observed that the younger generation, especially the students knowingly or unknowingly, are attracted towards **synthetic, artificially colored and other unsafe/unhealthy food**. Consumption of such kind of food may lead to life-threatening diseases like cancer, cardiovascular disease etc. at a very young age.

A consumer who is conscious about safe and hygienic food may definitely compel the Food Business Operators to ensure that the food they prepare and serve is safe and contamination-free, by asking few questions as and when they go out for eating. Undoubtedly, students of higher educational institutions like colleges, professional institutes etc. can play a major role in this area.


