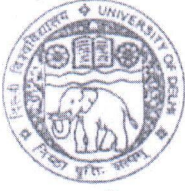

The University of Delhi announces the Schedule of the Special Cut-Off and the Sixth and Seventh Cut-off of Under-graduate (UG) Merit Based Courses as follows:

Process	Date
Applicants apply for the special Cut-Off	9:00 am 24 th Nov 2020 (Tues)- 1:00 pm 25 th Nov 2020 (Wed)
Colleges to approve applicants selected under special Cut-Off	By 5:00 pm 26 th Nov 2020 (Thur)
Last day of payment against Special Cut-Off	11:59 pm 27 th Nov 2020 (Fri)
Admission against 6 th Cut-Off	10:00 am 30 th Nov 2020 (Mon) – 5:00 pm 2 nd Dec 2020 (Wed)
Last day of payment against 6 th Cut-Off	11:59 pm 4 th Dec 2020 (Fri)
Admission against 7 th Cut-Off (if required)	10:00 am 7 th Dec 2020 (Mon) – 5:00 pm 9 th Dec 2020 (Wed)
Last day of payment against 7 th Cut-Off	11:59 pm 11 th Dec 2020 (Fri)

The process and policy of taking admissions under sixth and seventh Cut-Off will be as adopted in the earlier five Cut-Offs.

Guidelines for students applying for Special Cut-Off

- 1) Following applicants will be eligible/ not eligible to participate in the Special Cut-Off
 - a) Only those applicants will be considered who could not/ did not take admission in the initial five Cut-Offs for whatsoever reasons.
 - b) An applicant who has cancelled his/ her admission in the 5th Cut-Off will not be eligible to participate in the special Cut-Off.
 - c) Applicants who are already admitted (including NCWEB) in any course/ college of University of Delhi will not be eligible to participate in the special Cut-Off.
- 2) Applicants will apply to a single college + course. Applicants must ensure that they have carefully checked the number of seats vacant in the course + college they are applying to under their category.
- 3) The Cut-Off for various courses available under each category for a college who would be admitting students under Special Cut-Off will be available on the website of University of Delhi on 23rd Nov 2020 (Mon).
- 4) In case the number of applicants applying for a particular course in a college is more than the number of seats available, colleges will make a merit as per the Best of Four/ Best of three required for the course. The college will approve only those number of applicants as per the merit, as the number of seats available.
- 5) In case of a tie for a seat the following tie-breaking rule shall be applied
 - a) The applicant with higher percentage of marks (aggregate of best five subjects including one language) in the qualifying examination will be considered first for admission. ^[SEP]
 - b) The applicant with the earlier date of birth (as mentioned in class X certificate) will be considered for admission. ^[SEP]
- 6) Merely applying under the Special Cut-Off does not guarantee an admission to the applicant.
- 7) No grievances will be entertained in case an applicant fails to apply or pay the fees (if approved) within the stipulated time period given in the schedule.
