TERMS & CONDITIONS

- 1. Vendors/agencies who are Microsoft Authorized Education Reseller/Microsoft Certified Gold Partner are eligible to submit bids. The vendor/ agency must have experience of supplying Microsoft certified and licensed products to Govt. Research/ Academic Institutions/ Departments/Ministries/Delhi University or its colleges.
- 2. The quoted rates/ cost should be inclusive of all levies/taxes/ charges etc. The proposal submitted against this RfP should remain valid till at least six months from the last date of submission.
- 3. An Earnest Money Deposit (EMD) of 3% of the total cost or Rs. 10,000/- (Rs. Ten Thousand Only), whichever is lower, is required to be submitted along with the Bid in the form of Demand Draft/Bankers' Cheque/Pay Order from any nationalized bank payable at Delhi, drawn in favour of the Principal, Shri Ram College of Commerce.
- 4. EMD will be adjusted against the full & final payment of the successful bidder and will be refunded (without interest) to the unsuccessful bidder within 90 days from the last date of receipt of tender document. Bids not accompanying the EMD, will be summarily rejected.
- 5. The successful bidder will have to deposit a sum of 5% of the amount of bid as Performance Security to the college at the time at signing the contract. The Earnest Money paid by the bidder will be adjusted towards the performance security.
- 6. The Performance Security may be **FOREFEITED** in case the performance of the product is unsatisfactory or does not meet the specifications mentioned at the time of the bidding.
- 7. 100% payment after delivery of Microsoft Licenses & Certificates as per requirement, installation, training etc.
- 8. Vendors should submit the bids strictly in accordance with the information given in Bid Information Sheet.
- 9. Bids received within the stipulated time shall be opened as per schedule given in the Bid Information Sheet. The bidders may send their representatives on the stipulated date and time.
- 10. The successful bidder to whom the order shall be awarded will ensure delivery of the required products within 10 days of the award of order.
- 11. The college reserves the right to increase or decrease the quantity of required items.
